

In the wake of a tremendous loss, our seventh-grade students took on a meaningful writing journey to cope, heal, and grow. Following the passing of beloved teacher Mrs. Chavez, students took time to honor her legacy remembering her as an inspirational educator who left a lasting impact. This reflection served as the foundation for a writing assignment that challenged students to think critically about the life and legacy they hope to leave behind.



The assignment was a three-step process designed to emphasize the importance of revision and refinement. Students began with a first draft, organizing their thoughts and exploring their personal aspirations. After proofreading and making initial edits, they created a second draft, which was then peer-reviewed by a classmate. The final draft reflected not only improved sentence structure and clarity but also deeper, more refined personal insights. Each step reinforced the idea that writing is a process—one that requires careful thought, revisions, and growth.





Beyond writing mechanics, this assignment fostered self-awareness, goal setting, and reflection. Students had to clearly communicate their ideas, support their thoughts with evidence, and maintain an appropriate style and tone. More importantly, they were given the space to consider the impact they wish to have on others—just as Mrs. Chavez had on them.

Through this project, students not only strengthened their writing skills but also developed a greater appreciation for the power of their words and actions. Mrs. Chavez's legacy lives on in the thoughtful reflections of her students, who are now more mindful of the mark they hope to leave on the world.
